The elections have been conducted following the waiver guidelines listed in the Teachers Contract, requiring at least 75% approval. The results are in and once again, the staff at each school has overwhelmingly supported the continuation of the middle school model. The GEA Executive Board has also voted to give approval. Actual results this year were:

Lombard: 50 for, 5 against - 91% approval (3 of the no votes were due to absences)

As I have stated in the past, the middle school model is a very significant factor in the high achievement of Lombard. One would be hard pressed to find a middle school in the state of Illinois with 70% or greater poverty that achieves at a higher level than Lombard.
