Student is required to show proof of participation in a school sanctioned drug abuse/counseling program prior to re-enrollment in District #205.

May enroll, if accepted, on probation at GHS or GHS-N beginning Term 1 of the 2011-2012 school year provided documentation of successful assessment and subsequent treatment by a certified professional counseling provider is submitted to GHS by August 1, 2011. Credit recovery will be available as approved by building principal.
