Recommendation on Expulsion

Considering the information presented at the discipline hearing, it was recommended that one (1) Galesburg High School Student (Case #10-10), be expelled for the remainder of the 2009-2010

school year and expelled through the 2010-2011 school year. The student may return on probation to Galesburg High School or enroll if accepted on probation at the Galesburg Alternative School or Knox County Academy beginning Term 1 of the 210-2011 school year provided documentation of successful assessment and participation in an approved certified counseling program is submitted to Galesburg High School by August 1, 2010. Credit recovery is available as approved by building principal.
