Student may enroll at the Knox County Academy or Galesburg Alternative High School, if accepted, on probation beginning Term 1 of the 2010-2011 school year. Student may return to Galesburg High School or Galesburg Alternative High School on probation beginning Term 3 of the 2010-2011 school year. All enrollment is subject to providing documentation of successful assessment and participation in an approved certified counseling program; submitted to Galesburg High School by August 1, 2010. Credit recovery is available as approved by building principal.

Recommendation on Expulsion

Considering the information presented at the discipline hearing, it was recommended that one (1) Galesburg High School Student (Case #10-13), be expelled for the remainder of the 2009-2010 school year, expelled through the 2010-2011 school year and expelled through Term 2 of the 2011-2012 school year. Student may enroll at the Knox County Academy or Galesburg Alternative High School, if accepted, on probation beginning Term 1 of the 2010-2011 school year. Student may return to Galesburg High School or Galesburg Alternative High School on probation beginning Term 3 of the 2010-2011 school year. All enrollment is subject to providing documentation of successful assessment and participation in an approved certified counseling program; submitted to Galesburg High School by August 1, 2010. Credit recovery is available as approved by building principal.
