Therefore, it is our plan to bring a budget amendment to the board in November along with various financial projections for the district.

Member Kessler reported that the Building & Grounds Committee met September 8, 2014. package 1 for site Bid construction work was reviewed and approve. The bid package is scheduled to be out for bid on September 9, 2014. The bid opening will be September 23, 21014. We will need a special board meeting to approve the bid package on September 23, 2014. If all goes as planned, the notice to proceed construction will be issued for bid package 1 on September 30, 2014. The committee then viewed a presentation from Cordogan Clark Architects reviewing exterior and interior materials and finishes. The committee also reviewed building design updates.
