Call To Order/Roll Call

Closed Session

It was moved by Member Harrison and seconded by Member Swanson that the special meeting be adjourned to a closed session for two (2) student disciplinary cases—6:02 PM. Recommendation on Expulsion

Considering the information presented at the discipline hearing, it was recommended that a Galesburg High School student (Case #07-23), be expelled for the 2007-2008 school year and 2008-2009 school year. Student may return on probationary status to Galesburg High School Term 1 of the 2008-2009 school year. A stipulation of the probation will be, prior to re-admittance, the school's receipt of documentation by August 15, 2008 of student's successful participation in an approved anger management program.

It was moved by Member Swanson and seconded by Member Harrison that the Board of Education approve the above recommendation as stated. On roll call the following Members voted AYE: Panther, Harrison, Swanson, Strauch, Lindstrom, Nelson (6) Absent: Osborn (1) Motion carried. Roll Call #4

Considering the information presented at the discipline hearing, it was recommended that a Galesburg High School student (Case #07-24), be expelled for the 2007-2008 school year and the 2008-2009 school year. Student may return to Galesburg High School on probationary status Term 3 of the 2008-2009 school year provided documentation of successful participation in approved anger management program is provided to Galesburg High School by December 15, 2008. Student is to receive Home Study per mandate of IEP.

It was moved by Member Swanson and seconded by Member Nelson that the Board of Education approve the above recommendation as stated. On roll call the following Members voted AYE: Panther, Harrison, Swanson, Strauch, Lindstrom, Nelson (6) Absent: Osborn (1) Motion carried. Roll Call #5
