Call To Order/Roll Call

Closed Session

It was moved by Member Strauch and seconded by Member Panther that the special meeting be adjourned to a closed session for a student disciplinary case—6:00 PM. Action will be taken in open session. Recommendation on Expulsion

Considering the information presented at the discipline hearing, it was recommended that a Galesburg High School Student (Case #09-17), be expelled for the remainder of the 2009-2010 school year and expelled through the 2010-2011 school year. Student may return on probation to Galesburg High School or Galesburg Alternative School beginning Term 1 of the 2010-2011 school year provided documentation of successful assessment and subsequent treatment by certified professional counseling provider to Galesburg High School by August 13, 2010. Credit Recovery as approved by building principal. Home study per mandate of IEP.

Recommendation on Expulsion
